

## Operating Instructions. Safety instructions

### WARNING

TO REDUCE FIRE OR SHOCK HAZARD, DO NOT EXPOSE THE UNIT TO RAIN OR MOISTURE. TO AVOID ELECTRICAL SHOCK, DO NOT OPEN THE CABINET.

### SAFETY INSTRUCTIONS

#### POWER SOURCES

This charger should be operated only from the type of power source indicated on the marking label. If you are not sure of the type of electrical power supplied to your home, consult your dealer or local power company.

#### CLEANING

Unplug the charger from the wall outlet before cleaning or polishing it. Do not use liquid cleaners or aerosol cleaners. Use a cloth lightly dampened with a little bit water for cleaning the exterior of the set.

#### WATER AND MOISTURE

Do not use power-line operated sets near water - for example, near a bathtub, shower, washbowl, in a wet basement, or near a swimming pool, etc.

#### FOUDRE
